Dear requester,

Thank you for your recent request under the Freedom of Information Act 2000.

Section 1 of the Freedom of Information Act 2000 (FOIA) places two duties on public authorities. Unless exemptions apply, the first duty at, **Section 1(1) (a)**, is to confirm or deny whether the information specified in a request is held. The second duty at, **Section 1 (1) (b)**, is to disclose information that has been confirmed as being held.

The information that you are seeking is in relation to the following:

The number of people arrested for the common law offence of conspiracy to cause a public nuisance.

Of these arrests, the number that resulted in a charge.

I would like this data broken down by month — I.e. January 2012, February 2012, etc.

I would like this data broken down by month — I.e. January 2012, February 2012, etc.

Please note the system used for data extraction only goes back to 2020.



The data provided for arrests is based on custody footfall, this means that if someone was arrested for multiple offences, they will only be counted once as they were arrested once.

If arrested for the same offence separate times they will be counted each time they came into custody.

Please note that a person may be arrested under one offence but then it may be dealt with via another offence therefore we have provided the final offence that is linked to the disposals.

The following data includes the offence titles below:

Cause a public nuisance.

Conspire to intentionally / recklessly cause a public nuisance.
