Dear requester,

Thank you for your recent request under the Freedom of Information Act 2000.

Section 1 of the Freedom of Information Act 2000 (FOIA) places two duties on public authorities. Unless exemptions apply, the first duty at, **Section 1(1) (a)**, is to confirm or deny whether the information specified in a request is held. The second duty at, **Section 1 (1) (b)**, is to disclose information that has been confirmed as being held.

The information that you are seeking is in relation to the following:

REQUEST

I am requesting the following information please in relation to speed recording and speed van deployments specifically in the Devauden area of Monmouthshire.

In 2025 the dates that speed recording equipment was placed in the village of Devauden, (The static rubber lines that are placed across the road). For these dates the recorded speeds of vehicles especially with the highest recorded vehicle speeds with times and dates.

Further to this the speed vans have been seen in and around the village, so the dates and times they were parked in the village and how many vehicles were then caught speeding.

RESPONSE

Speed van locations are published on the GoSafe website, and all sites are privy to strict risk assessment criteria as well as KSI (Killed or Seriously Injured) and speed data analysis.

The strips across the road are speed monitoring by the council and therefore they would have all that data.

We have our own speed monitoring equipment, but it does not entail the ones that lay across the roads.
